

Suggested Changes to Offense Seriousness Level Rankings

Vehicular Homicide Disregard for the Safety of Others

RCW 46.61.520(1)(c)

Increasing from seriousness level VII to level VIII to more appropriately reflect the immense gravity and irremediable nature of the crime.

An offender can spend less than a year in jail if they have no criminal history while the traumatic grief imposed upon the family has lifelong impacts. There are very few support groups or services in place specific to vehicular homicide and Crime Victims Compensation caps the grief counseling benefit at 12 sessions total for immediate family members only. The current sentence and treatment of these crime victims is not just. Following the logic that Vehicular Homicide by being under the influence of an intoxicant and by operating a vehicle in a reckless manner are ranked with Manslaughter in the first degree, Vehicular Homicide by disregard for the safety of others should be ranked with the similar offense of Manslaughter in the second degree. Decreasing the seriousness level, which is currently a level VI offense.

In order to charge Malicious Placement 1, intent to commit a terrorist attack must be proven, but the second degree designation is broad and may encompass bomb threats or pranks perpetrated by youthful offenders. The sentence length cannot be justified by deterrence alone, as we understand it to be a flawed legal concept, and it doesn't seem appropriately ranked with other level VI crimes against persons, such as Incest 1 or Rape of a Child 3. Increase seriousness level from level IV to level V.

Along with Assault 2 this is the only other offense in seriousness level IV, which results in substantial bodily harm. A Vehicular Assault victim may be faced with long-term rehabilitation and collateral costs at his or her own expense, as crime disproportionately impacts indigent persons. An incident of Vehicular Assault can very easily cause long-term disability, contributing to further social closure. [Maia McCoy]

Increasing the severity level of from level IV to level VI.

The difference between Assault 1, which carries a seriousness ranking of XII and Assault 2, carrying a seriousness level of IV, is too wide-ranging. An offender with no prior criminal history charged with Assault 2 could receive fewer than 2 months in jail, versus 5.8 years on the Assault 1 charge. Currently, the minimal sentence for Assault 2 does not provide incentive for assault survivors to testify against the assailant. Most victims are reluctant to cooperate and compromise their own safety, if they know an offender is going to be immediately released. Assault 2 requires a finding of substantial bodily injury -- broken vertebra, stab wounds, and so forth, which is not consistent with other offenses at seriousness level IV, such as Influencing Outcome of a Sporting Event and Identity Theft 1. Assault 2 is commonly charged in cases of strangulation and other crimes against women. While we have long minimized gender-based violence, our cultural mores are shifting, and public policy including sentencing should reflect that. [Maia McCoy]

Suggested Changes to Offense Seriousness Level Rankings

Assault in the Second Degree is a class B felony. There is a considerable gap in the ranking of Assault in the First degree (seriousness level 13 now and proposed level 12) vs. Assault in the Second Degree (seriousness level 4). Assault in the Second Degree can be committed by a variety of actions (sub-sections a – g) with a variety of resulting injury to the victim. For example, the actions that constitute an assault by strangulation could quickly become the actions for a homicide by strangulation. This type of action with the potential consequences should have a higher seriousness level. On the other hand, infliction of fear of an assault without physical injury (for example by use of a deadly weapon that does not inflict injury) is qualitatively different. *The Assault 2 crime should be classified differently as to the specific sub-category in the statutory definition.* The different sub-categories may be used for a B+ to B to B- categorization. Assault in the First Degree may also be broken down to sub-categories because of the different ways the crime could be committed. This is a way to bridge the gap between the present spread between the two crimes of Assault in the First Degree and Assault in the Second Degree. This could be done whether we continue to use the current seriousness level grid or whether we move to the A+ through C- grid. [Judge Houser]

Theft of Livestock in the First Degree (RCW 9A.56.080) is a level 4 offense. Identity Theft in the First Degree is also a level 4. Trafficking in Stolen Property in the First Degree is a level 4. In my opinion, Theft of Livestock should be treated as any other theft. Theft 1 is a level 2 crime and Theft in the Second Degree is a level 1. *I would place Theft of Livestock in these two levels based upon either the type of livestock (more expensive vs. less expensive) or by value in level 1 and 2.* [Judge Houser]

Theft of Ammonia (RCW 69.55.010) is a C felony with a maximum prison sentence of 5 years. It is a level 8 crime. A defendant with an offender score of 5 faces a sentence of 46 – 61 months. This is not appropriately placed in the present guidelines grid. *I would place it at the same seriousness level as Theft in the First Degree.* [Judge Houser]

There are a series of crimes concerning automobile air bags (RCW 46.37.660). Each of these crimes is a C Felony with the maximum penalty of 5 years. They are listed as a level 5 or level 7 crime. A defendant reaches the maximum statutory penalty in an offender score 6 or 7 . *These should be reclassified as a level 3 crime.* The maximum statutory penalty would then be reached at a level 9. All Failure to register offenses should be level 1. The crime is a failure to file a form with the local sheriff's office. Under the R group proposed grid, the crime should be a C- and B- as presently designated; however, since the crime is the failure to file a form with the sheriff, the crime should be a C felony at the most. RANGE EXCEED STATUTORY MAXIMUM

I have mentioned a couple of instances where the statutory maximum sentence is below the seriousness level 9 sentencing range. We should take a look at any crime where this occurs and place the crime in a seriousness level that is appropriate where the maximum statutory sentence may not be reached unless the offender has an offender score of 9 or greater.
