II. DRAFT LEGISLATIVE BILLS

Hearings scheduled for week of 1/22/2024

- a. HB 1967 Excluding any person who is convicted of a hit and run resulting in death from being eligible for a first-time offender waiver.
- b. HB 2001/SB 6037 Providing judicial discretion to modify sentences in the interests of justice.
- c. HB 2079 Improving school safety by extending and increasing penalties for interference by, or intimidation by threat of, force or violence at schools and athletic activities.
- d. HB 2169 Concerning a pilot program creating a healthier environment for correctional officers, department of corrections staff, and individuals within a correctional facility.
- e. SB 5938 Modifying the community parenting alternative for eligible participants in the residential parenting program at the department of corrections.
- f. SB 5953 Concerning financial aid grants for incarcerated students
- g. SB 5891/HB 2133 Designating trespassing on a public school bus as a felony offense.
- h. SB 6200 Concerning penalties related to eluding police vehicles and resisting arrest.

Bills that are had a policy committee hearing but have not yet been reviewed by SGC

- i. HB 2030 Revoking a person's voting rights only when convicted of a state crime punishable by death.
- j. HB 2153 Deterring the theft of catalytic converters.
- k. HB 2171 Addressing financial aid grants for incarcerated students.
- l. HB 2203 Creating a pilot project to assist incarcerated veterans.

- m. HB 2303 Modifying conditions of community custody.
- n. SB 5841 Requiring individuals convicted of offenses related to driving under the influence to pay financial support to minor children and dependents when the offense results in the death or disability of a parent.

Bills not yet scheduled a hearing

- o. HB 2002 Establishing criminal penalties for the public use of fentanyl or methamphetamine.
- p. HB 2057 Creating a pilot project to assist incarcerated veterans' transition to civilian life.
- q. HB 2078 Improving school safety by extending and increasing penalties for interference by, or intimidation by threat of, force or violence at schools and school-related athletic activities.
- r. HB 2220 Concerning violent offenses.
- s. HB 2225 Giving people with criminal records who are rehabilitated a fresh start in occupational licensing in Washington.
- t. HB 2227 Vacating a conviction for driving under the influence, actual physical control of a motor vehicle while under the influence, or an offense considered a prior offense to such convictions.
- u. HB 2358 Making obstructing highways a crime.
- v. SB 6051 Concerning manslaughter when certain controlled substances are sold that result in death of the user.
- w. SB 6070 Concerning the most serious offenses.
- x. SB 6133 Deterring robberies from cannabis retail establishments.
- y. SB 6160 Concerning penalties for unlawfully obstructing traffic.
- z. SB 6217 Deterring robberies from retail establishments
- aa. SB 6261 Concerning penalties for the theft and possession of stolen property, including theft from first responders.
