Suspended Sentence

- > Treatment-based option.
- > Judge must find that defendant and community would benefit from suspended sentence.

FTOW PROPOSALS

- > Standard range is suspended and the defendant is allowed to serve their sentence on community supervision.
- If fail to comply with conditions, suspended sentence may be revoked and defendant served sentence in jail/DOC.

Prison sentence-based for SL 6 through 10

- Sentence to the minimum to be served in a combination of incarceration and community supervision.
- The portion of the sentence to be served in confinement may not exceed half of the minimum or 12 months, whichever is less.
- Confinement to be served in local jail.
- The remainder of the sentence to be served in community supervision.
- The period of community supervision must be at least half of the minimum or 6 months, whichever is greater, if the individual is not ordered to complete treatment.
- The period of community supervision must be at least half of the minimum or 12 months, whichever is greater, if the individual is ordered to complete treatment.

Jail sentence-based for SL 1 through 5

- > Sentence to be served on community supervision.
- Current FTOW rules apply, except the 0-90 days of confinement.
