I. CALL TO ORDER

Chair Judge Saint Clair called the meeting to order.

II. **DRAFT LEGISLATIVE BILLS**

HB 1178 - Concerning sentencing enhancements

Keri-Anne briefed members on the bill and the positions the SGC took on similar bills in previous legislative sessions.

Ramona Brandes added that unlike last year's bill, this bill does not include other enhancements, such as school zones, which created controversy last year.

HB 1125 - Providing judicial discretion to modify sentences in the interests of justice. Keri-Anne noted that this bill was supported by the SGC last year, with Judge Amamilo testifying on behalf of the SGC. The SGC also submitted a letter of support to the Legislature. Kimberly Gordon was invited to speak to the members.

Kimberly Gordon noted that there have been two significant amendments from the last bill that had been brought to the Legislature. The first addressed concerns about workload by the counties, prosecutors and the courts. A tiered triage plan was created for establishing eligibility to petition over seven years. Also, the Office of Public Defense has contracted with private attorneys who are experienced in resentencing and are willing to take on these cases. The second is that the bill provides services for victims and survivors. Dr. Lauren Knoth-Peterson presented data on estimated eligible individuals that she received from the Office of Public Defense.

HB 1166 - Establishing the providing effective education for reentry success act.

Dr. Matthews asked Secretary Lang if DOC had any concerns about implementation of this bill. Secretary Lang replied that DOC has concerns around the fiscal impact, the staffing necessary to accommodate it, as well as safety and security concerns associated with having that sort of equipment available.

HB 1111/SB 5266 - Concerning the indeterminate sentence review board.

Katie Hurley was invited to provide a brief review of the bill.

Ramona Brandes remarked that this could help alleviate some of the overcrowding situation and that the SGC has been discussing this bill extensively.

HB 1152 - Enhancing public safety by establishing secure storage requirements for firearms in vehicles and residences.

Ramona Brandes proffered that this bill is criminalizing negligent behavior and that making the offense as an unranked class C felony is commensurate with a gross misdemeanor and seems appropriate. Dr. Knoth-Peterson added that Unsafe Storage of a Firearm 2 is a gross misdemeanor. Dr. Knoth-Peterson observed that the new offenses in Section 1 have nearly identical language as found in Section 4 (RCW 9.41.360). She went on to note that it seems the bill is expanding the definition of Unsafe Storage but not creating new offenses. Ramona Brandes suggested that the bill should amend the current statute to fit with the new definitions instead of creating a new crime that conflicts with existing language.

SB 5152 - Concerning state employee access to peer-reviewed journals.

Keri-Anne briefed the bill and provided background on access issues she has experienced. Since the SGC is asked to advise the Legislature and governor, the need for access to these articles and journals is crucial. Dr. Matthews agreed and said that the state can't support evidence-based policies if people aren't provided access to that evidence. Jon Tunheim expressed surprise that this access is not available.
